# **PRIVACY POLICY**

This privacy notice details what information we store about our customers of Home From Home Perthshire and how we keep your personal details safe.

This privacy notice will hold the latest information regarding what we hold and what we use it for and will be updated as and when required.

This privacy notice sets out the way we process and store your information. We will always refer to this page when we ask you for your consent. We will keep this page updated to show you all the things we do with your personal information so that you can be confident when sharing your information with us that it will only be used for the purposes that we state here.

# General Data Protection Regulations (GDPR)

Under the General Data Protection Regulations Protection Act, we have a legal duty to protect any information we collect from you. We use leading technologies and software to safeguard your data and keep strict security standards to prevent any unauthorised access to it.

## Information we hold

# How we collect personal information

We collect information about you in the following ways:

#### If you are under 16 years of age

#### How we use personal information

# How your browsing information is used

- Ensure that content from our site is presented in the most effective manner for you and for your computer.
- Allow you to participate in interactive features of our service, when you choose to do so.
- Protect the integrity of our servers to protect our website and other visitors

Please note that if you click on, or follow, any links from our site to external websites, our privacy policy will no longer apply.

Please check the privacy policies of any such external site before submitting any personal data, as we cannot accept any responsibility or liability in relation to them.

#### Who we share information with

Under strictly controlled conditions data may also be shared with:

- Contractors/Suppliers/Appointed Agents of Home From Home Perthshire
- Organisations when required by law for the purpose of the prevention or detection of crime.

When we allow access to your information, we will always have complete control of what contractors/suppliers see, what they are allowed to do with it, and how long they can have access to it.

We do not sell or share your personal information with any other organisations for Commercial purposes.

# **Data Storage**

All information you provide to us is stored on our secure, encrypted servers within the EEA. All transactions will be encrypted using SSL technology.

We take your privacy very seriously, and will take all reasonable steps to protect your personal data, but please be aware that any data which you send to our site is sent at your own risk.

The data that we collect from you for marketing purposes may be transferred to, processed and/or stored at a destination outside the European Economic Area ("EEA").

By agreeing to receive our email newsletters you agree to this. We will take all reasonable steps to ensure that your data is treated securely and in accordance with this privacy policy.

# Disclosure of your information

We may disclose your personal information to third parties in the following circumstances:

- If we are required to do so by law, any applicable regulation or to protect the rights, property, or safety of ourselves or others.
- This may include disclosing to other companies and organisations in connection with fraud protection and credit risk reduction.

#### Consent

Where we need your consent, we will ensure that you are as fully informed as possible at the time on what we do with your information, with whom it may be shared and how long we keep it.

This is in line with the requirements of the current General Data Protection Regulations and other relevant legislation.

## Accessing your personal data held by Home From Home Perthshire

You have the right to request, in writing, a copy of all the personal data we hold about you. This is a 'Subject Access Request'.

Requests for access to personal data (other than those falling within routine business) should be addressed in writing to:
